Program Descriptions

Tax Assistance

▪ **Property Tax Circuit Breaker:** for qualifying seniors, the Property Tax Circuit Breaker may reduce your state income taxes by up to \$970, or give you a rebate. Call the Council On Aging at (508) 238-3160.

▪ **Property Tax Exemptions:** Easton offers tax exemptions for seniors, veterans, legally blind and other qualifying taxpayers to the fullest extent allowed by state law. Requirements vary for different exemptions. Contact the Assessors at (508) 230-0520 for information.

▪ **Tax work-off program:** qualifying homeowners age 60+ may earn a property tax discount of \$1000 for working in a Town office, doing rewarding work that helps the community. The rate is \$8.00/hour. Call the Council on Aging at (508) 238-3160.

▪ **Tax deferral program:** qualifying homeowners age 65+ may defer all or part of their property taxes until the property is sold or transferred. The Town then receives deferred taxes plus 3% annual interest. Contact the Assessors at (508) 230-0520.

▪ **Tax abatements:** residents who believe that their real estate, motor vehicle or personal property was incorrectly assessed may contact the Assessors to request abatement through an appeal process. The appeal period varies based on the particular tax. Call the Assessors at (508) 230-0520.

School Fee Assistance

▪ **School Fee Exemptions:** fees for school-related services such as lunch, sports, arts participation may be waived or reduced. To learn more, call School Administration at 508-230-3200 x213.

Child Care Assistance

▪ **Old Colony YMCA Easton Branch: Before and after School Programs.** Ask for a Financial Assistance form. The YMCA also offers a reduced fee structure for membership (determined by household income). Call (508) 238-9758.

▪ **Work Permits:** 14 thru 17 yr olds. The application is downloaded at: the Easton [School Superintendent's website](http://www.easton.ma.us). The permit is obtained through School Administration (508) 230-3200 (Select 2 on menu option).

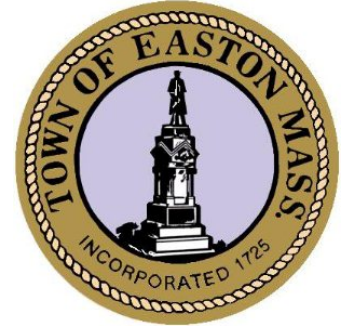
