

Scheduled Construction Activities for the Week of August 19, 2019

During the week of August 19, 2019, C. Naughton Corp is tentatively scheduled to perform the following construction activities:

- Two crews will be installing water main between the Five Corners Intersection and Poquanticut Avenue. Please note that in an effort to minimize traffic congestion, one crew will be working overnight on Monday from 12:00 AM to 8:00 AM in the intersection of Five Corners in an effort to clear the intersection before peak daytime traffic begins. Residences and businesses along Foundry Street will be turned over to the temporary water system and will be notified of a short-term service interruption by the contractor.
- Crews will also focus on general site housekeeping and maintenance; weather permitting, trench restoration activities may occur during the week.



Traffic Note

With the work extending from Five Corners to Poquanticut Avenue, eastbound traffic will no longer be allowed on Foundry Street. For example, a left-turn movement from Poquanticut Avenue onto Foundry Street is no longer possible. Similarly, local traffic from South Street, Gaslight Lane, Lamplighter Lane, and residences along Foundry Street will be directed to the west when entering Foundry Street. This condition will also remain in effect for the foreseeable future 24 hours a day, 7 days per week.



Support Local Businesses During Construction

Locally owned businesses recycle a large share of their revenue back into the local economy, which helps enrich the whole Town of Easton. The Department of Public Works encourages you to support local businesses throughout the duration of the Five Corners Sewer Construction Project.



The Foundry Street detour is operational and will remain in place 24 hours a day, 7 days per week until the winter months when it will be deactivated. It may be necessary to reactivate the detour in the spring of 2020 for roadway restoration activities. Traffic monitoring will continue throughout the project, and adjustments will be made as necessary.

Construction activities will be performed Monday through Friday between the hours of 7:00 a.m. and 4:00 p.m. Please plan ahead for travel and expect delays. The Town of Easton appreciates your patience during this construction project and reminds everyone to please drive safely.
